Cement 5-1/2" casing with 155 sxs Pox at 12.4 ppg (Yield 2.1ft/sx) followed by 700 sxs Class "C" @ 14.2 ppg (Yield 1.3 ft3 .sx). Displaced with brine water. Bumped plug with 2400 psig. Bleed pressure off, floats held ok.
