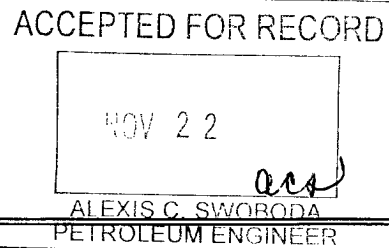

11/11/05 Set 9-5/8" 36# J-55 ST&C casing at 3250'. Cemented stage 1 with 315 sx 35:65 "C" + 2% CaCl₂ + 1/4#/sx Celloflake + 5% LCM-1 (yld 1.98, wt 12.5). Tailed in with 200 sx "C" + 2% CaCl₂ (yld 1.34, wt 14.8). Cemented stage 2 with 325 sx "C" + 2% CaCl (yld 1.96, wt 12.5). Tailed in with 100 sx Class "C" + 2% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. Ending psi 1495. WOC 26 hrs. Reduced hole to 8-3/4" and resumed drilling.
