10/17/05 Perforate Silurian 6152'-6162' (44).

10/20/05 Perforate Silurian 6068'-6074', 6099'-6104' with a total of 52 holes. Acidize with 500g 20% IC acid.

10/26/05 Set CIBP at 6000' with 35' cement on top. Set CIBP at 5800' with 35' cement on top. Perforate Wolfcamp 5426'-5430' (10). Acidize with 500g 20% IC acid.

10/31/05 Perforate Wolfcamp 5166'-5174' (36). Acidize with 1000g 20% IC acid. Set RBP at 5230'. Set packer at 5126'.
