The production from the Federal C 35 #4 is sent to the Station 235 facility. This facility consists of two 3-phase separators. The production manifold allows for individual well testing in the test separator while production from the remaining wells flows to the production separator. After separation, the gas and liquids will be handled in the same manner described in the paragraph titled "Station 235 Facility" in the current commingle agreement. I have attached an updated diagram of this facility and copies of this diagram will be sent to the Carlsbad office as well, to update their site security diagrams for this facility.
