Tailed in with 520 sx Super "H" SBM + 0.5% Halad-344 + 0.4% CFR-3 + 1# salt + 0.2% HR-7 (yld 1.66, wt 13). Cement did not circulate. Tested casing to 1500 psi for 30 min. WOC 55 hrs. TOC at 1350' approx. Reduced hole to 6-1/8" and resumed drilling.
