Slips were knocked out but would not fall. May be something under it. At 1820' there is over 50' of rathole so will leave second partially drilled CIBP at 1820'. POOH. RD.

8/26/2002 RU RIH w/bull plugged 3' perf sub (3.6'), SN (1.10'), and 55 jts 2 3/8" 8rd EUE 4.7# tbg (1717.88'). SN at 1718'. RIH w/1"x 6" gas anchor, 2"x1 1/2" x 10' traveling barrel double valved pump, 1-2' 5/8" sub, 37 5/8" rods, 31 3/4" rods and 1 1/4" x 10' polished rod. Spaced well out. RD. I & W straightened PU and hung well on. Returned to production.
