Yates Petroleum Corporation plans to plugback and recompleate this well as follows: Rig up all safety equipment as needed. POOH with tubing and production equipment. Make a brief attempt to get the RBP at 8930', if unable to retrieve, leave it in the hole. Set CIBP at 8754' with 35' cement on top. Perforate Strawn 8360'-8364' (9). Stimulate as needed. Set a composite flow through plug at 8250' and perforate Strawn 8204'-8216' (73). Stimulate as needed. Perforate Canyon 7896'-7906' (21). Stimulate as needed. If the lower intervals are productive, consider commingling after the paper work has been approved.
