

The New Mexico Oil Conservation Division District 2 (OCD) is in receipt of an Initial Report C-141 reporting a release of produced fluids at the above referenced site. The C-141 submitted indicates, "...soil will be removed, allowed to dry, and OCD will be notified 24 hrs prior to testing."

- Notify OCD 24 hours prior to obtaining samples where analysis of samples obtained are to be presented to the OCD
- Submit a Final Report C-141 upon satisfactory completion of project.
