- Salt water disposal line (SWD). The surface line will be a 4" SDR9 poly(125 MAOP) following the existing roadway, 136.67' NE/4NW/4 of Sec 13, T25, R26
- Gas Pipeline. The buried gas lines will be one- 4" and one- 6" steel lines placed in the same ditch following the same route as the surface Salt water disposal line. 165.75' NE/4NW/4 of Sec 13, T25, R26
- Electric line. The 2 pole, 12.5 KV, 3 phase, 4 wire overhead electric line will tie into our existing line at the NE/4NW/4 of Sec 13, T25, R26. 105.70' NE/4NW/4 of Sec 13, T25, R26




