A review of the subject well reveals this well has been placed in a wrong pool designation. The correct pool designation should be 98164 WC-015 G-07 S242712P;Upr Wolfcamp. This is an oil pool and representative of this well's corrected classification and location. Dedicated acreage will reduce from 320 acres to 160 acres. I am making this change in our records today; therefore, this well cannot be reported under pool 97442 Black River;Wolfcamp, East (G) subsequent to today. Additionally, production previously reported to pool 97442 will need to be amended to pool 98164.
