Drop cancellation plug, pressure up to 2500#, WOC. 9/9/15, Install packoff, test to 5000#. RIH & tag DVT, drill out DVT, RIH & tag cmt @ 7004', test casing to 4823#, good test. Drill new formation to 7100', perform FIT test EMW=12.5ppg, 1200psi, good test.
