Pressured up on 4-1/2" casing valve. Well has a slow leak.  
Removed tubing and packer.  
Packer and tubing are in good shape. Packer element has some evidence of a leak past the element.  
Tagged fill at 2563'.  
Drilled out to original PBTD of 2700' GL.  
Ran AD-1 tension packer and 2-3/8" 4.7# EU IPC tubing to 2433' KB.  
Set Packer and pulled 12,000 lbs. tension on tubing and packer.  
Tested annulus to 500 psi and held for 15 minutes. No pressure loss.  
MIT was conducted on 8/6/2015 and was chart recorded and witnessed by OCD Representative.
