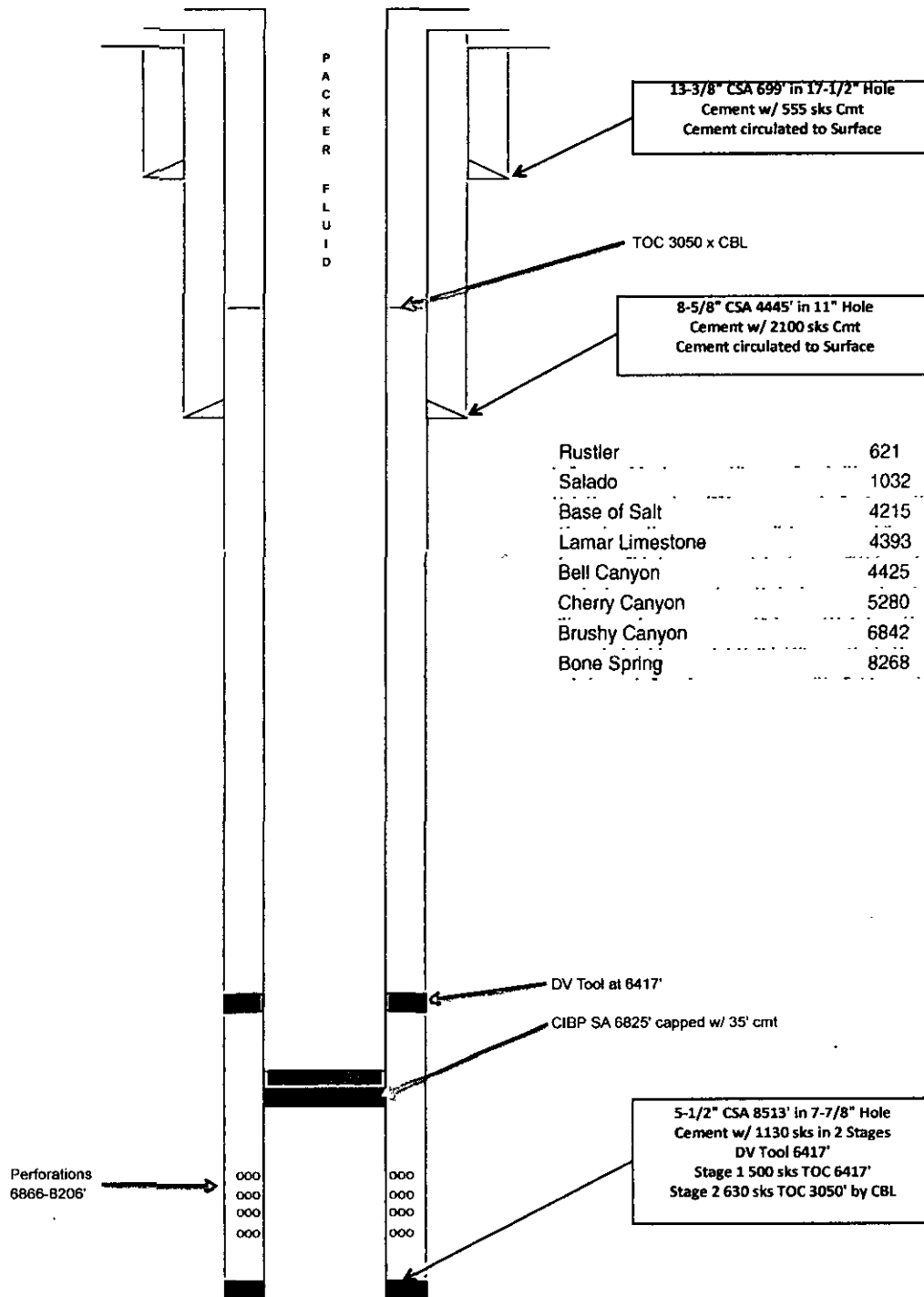

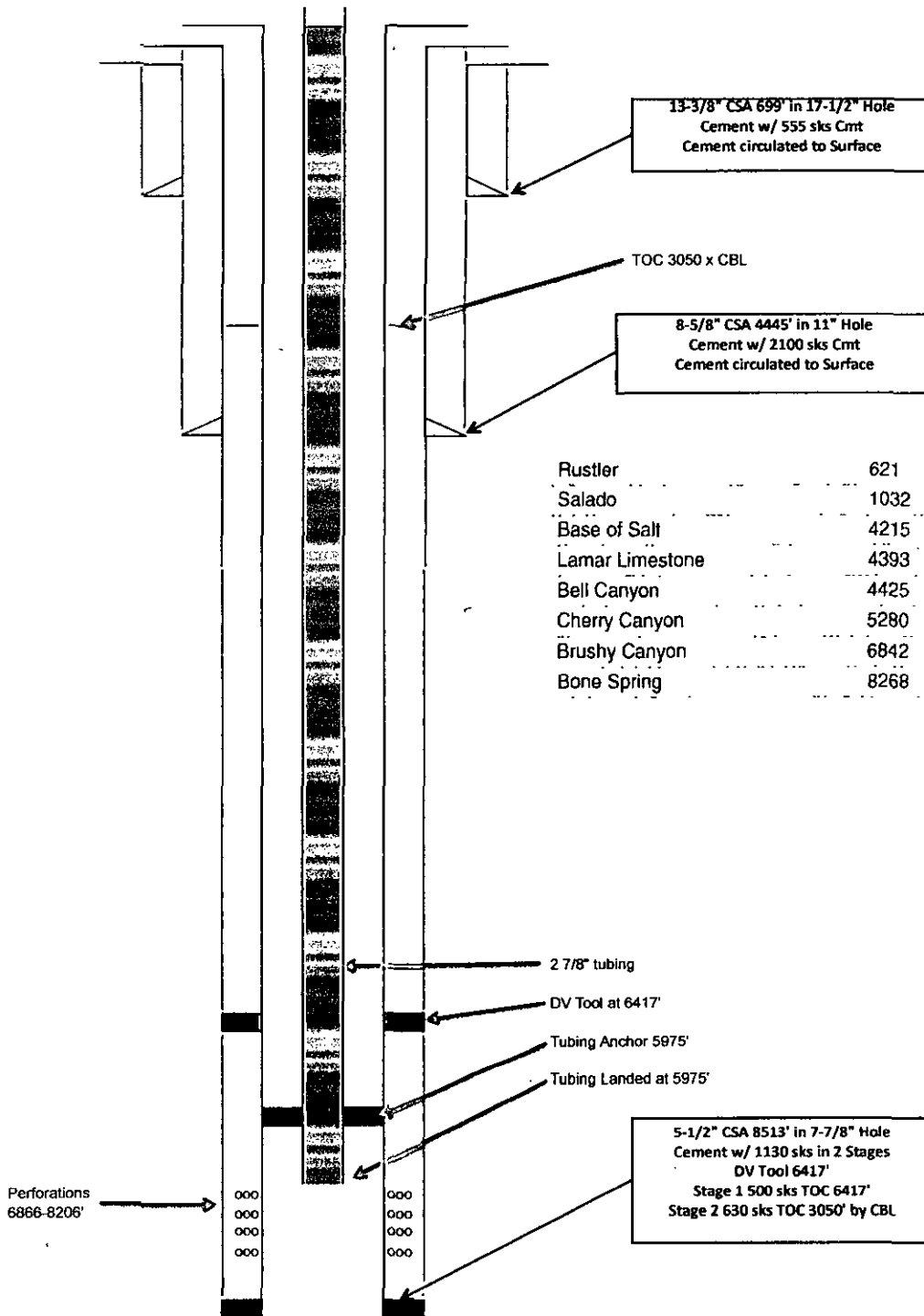
CURRENT WELLBORE DIAGRAM
