Shut-in of Well on Federal Lands Conditions

As per your Sundry request the above well is Shut-in (SI). The Bureau of Land Management (BLM) definition of a shut-in well is a completion that is physically and mechanically capable of production in paying quantities or capable of service use. 43 CFR 3162.3-4 (C) requires that wells incapable of production in paying quantities be promptly plugged and abandoned and requires approval for any well temporarily abandoned for more than 30 days.

As you have stated in your sundry this well is uneconomical due to necessary changes.

Do one of the following.

1. Comply with Notice of Incidents of Noncompliance and return the well to production.
2. Submit notice of intent to plug and abandon.

If you decide to plug and abandon the well, submit a Sundry Notice (form 3160-5) describe the proposed plugging program.

If you decide to return the well to production, submit a Sundry Notice (form 3160-5) of intent. Include the date you anticipated the well being placed back in service. 43 CFR 3162.4-1(c) also requires you to notify the Authorized officer, not later than the fifth business day after production is resumed for any well which has been off production for more than 90 days, the date on which such production was resumed. Notification may be by letter or Sundry Notice, or orally followed by letter or Sundry Notice.
