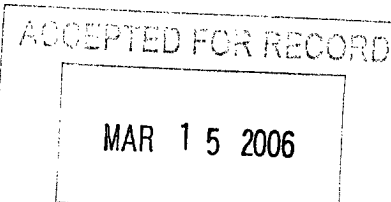

Tailed in with 200 sx Class "C" + 2% CaCl₂ (yld 1.35, wt 14.8). Cemented stage 2 with 450 sx 35:65:6 Poz "C" + .25#/sx cellophane flakes + 5#/sx LCM-1 (yld 1.95, wt 12.5). Tailed in with 200 sx Class "C" + 2% CaCl₂ (yld 1.35, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 54 hrs 15 min. Reduced hole and resumed drilling.
