Intermittent flaring was necessary due to restricted pipeline capacity.

Total of 2949 MCF was flared.

October - 5190 MCF

November - 2204 MCF

December - 609 MCF

Gas was flared due to high H2S content. No economic alternative is currently available to put gas in marketable condition.

Gas was metered prior to flare and flared amounts reported on monthly production reports.
