We need to run three 4-inch surface poly pipelines from our Cal-Mon 35-21H well to our Cal-Mon #5 SWD, in order to dispose of produced water without having to use trucking.

The proposed pipeline route is 4,092.60 feet in length, 30 feet in width, crossing BLM Land in Section 35, T23S-R31E, as per the attached survey plat.

The entire route is within the boundaries of a single BLM oil & gas lease, and therefore does not need a ROW Application.

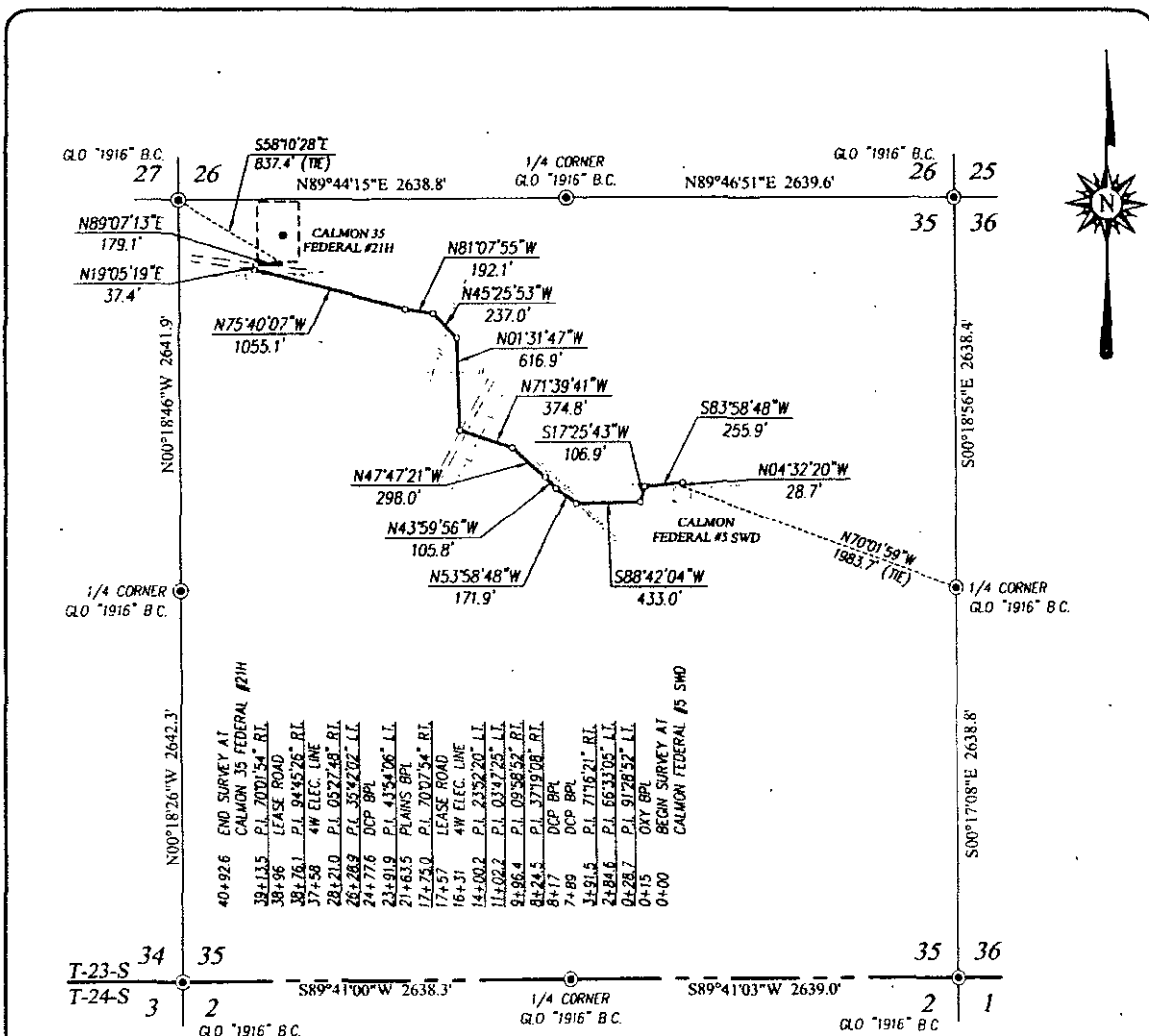

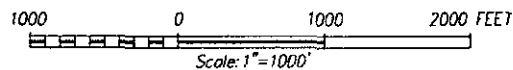
