COG proposes to drill a 17-1/2" hole to 300' w/fresh water mud system, wt 8.5, vis 28, set 13-3/8" casing and cement to surface. Drill a 12 1/4" hole to 850' w/br mud system, wt 10, vis 30, set 9 5/8" casing and cement to surface. Drill a 8 3/4" hole to 9784' w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 7" x 5 1/2" tapered casing string and cement to surface. Note: on production string, a caliper will be run. COG will attempt to circulate.
