The cellar boards were removed, back-filled, and leveled to match existing contours. Site and road was ripped, and the pad was re-contoured to match surrounding terrain. It is my understanding that Beth Skaggs, Natural Resource Specialist (BLM's Roswell Office), has been on location and inspected the completed work.

At this time, Scythian, Ltd., respectfully requests an extension for Seeding up until September 15, 2012. At which time seeding has been completed, we will file a Final Abandonment Notice.

Due to drought conditions throughout the summer (2012) seeding was postponed.
