W/5-1/2" RBP @ 2690' & 5-1/2" PKR @ 2675', PT RBP to 3500 psi-OK & 5-1/2" csg to 2000 psi-OK. TOH. RDWOU. Set 5-1/2" CBP @ 2980'. (Existing Yeso perms are @ 2700'-2955' & 3001'-3970'). On 6/29/16, treated existing Yeso perms 2700'-2955' w/1500 gal 15% HCL & fraced w/257,460# 40/70 Arizona sand in slick water.

Set 5-1/2" CBP @ 2686' & PT CBP & 5-1/2" csg to 3500 psi-OK. Perfed upper Yeso @ 2530'-2672' w/1-0.42" spf. Total 28 holes. Treated w/1500 gal 15% HCL acid & fraced new Yeso perms w/29,340# 100 mesh & 211,180# 40/70 Arizona sand in slick water.

On 7/5/16, MIRUSU. CO after frac, & drilled out CBPs @ 2686' & 2980', & CO to PBTD4270'. On 7/7/16, landed 2-7/8" 6.5# L-80 tbg @ 4044'. Ran pump & rods. Released completion rig on 7/8/16. Completed the well as a single Yeso oil well.
