Describe Cause of Problem and Remedial Action Taken.*

A water transfer road crossing line was damaged by possible malicious mischief causing an 8 barrel spill of treated water on the lease road approximately 3220 feet to the north of the Cotton Draw Unit 238H. Line pinchers were applied to both the upstream and downstream lines to isolate the leak and the damaged line and left flange were replaced.

Describe Area Affected and Cleanup Action Taken.*

8 barrels of treated water were spilled on the lease road and 0 barrels were recovered. The spill ran in a southwest direction covering an approximate 40 foot by 40 foot area. The contaminated soil was placed on a plastic liner to prevent further leakage. An environmental company will be contacted for remediation.
