6/9/17 - MIRU. Bled well down. Pumped 60 bbls water to clean rods and test. POH with rods and pump.
6/12/17 - Pumped 50 bbls brine to kill well. ND wellhead and NU BOP. Ran GR to 2300'. Set a 4-1/2" CIBP at 2297'. Ran gyro survey from surface to 2280'. Tagged CIBP at 2297'. Loaded and circulated well with 50 bbls plugging mud. Pressure tested CIBP and 4-1/2" casing to surface to 500 psi, good. Spotted 40 sx Class "C" cement from 2297'-1719'.
6/13/17 - Tagged TOC at 1692'. Spotted 25 sx Class "C" cement at 997'. WOC. Tagged TOC at 550'. ND BOP. Spotted 30 sx Class "C" cement at 480' and circulated cement to surface. Topped off 4-1/2" wellhead with cement.
6/15/17 - Cut off wellhead and installed dry hole marker. Cut off anchors and backfilled cellar. WELL IS PLUGGED AND ABANDONED.
