6/9/17 - MIRU. Loaded tubing, tested to 500 psi, good. Bled down.  
 6/12/17 - ND wellhead and NU BOP. Set a 7" CIBP at 7746'.  
 6/13/17 - Tagged CIBP at 7746'. Ran survey from surface to 7700'. Pumped 215 bbls fresh water. Tested casing to 500 psi, good. Displaced hole with 140 bbls brine mud gel. Spotted 25 sx Class "H" cement from 7746'-7576' calc TOC.  
 6/14/17 - Tagged TOC at 7589'. Spotted 35 sx Class "C" cement from 5486'-5260'. WOC. Tagged TOC at 5260'. Spotted 35 sx Class "C" cement from 4227'-4012' calc TOC. Spotted 35 sx Class "C" cement from 2000'-1785' calc TOC. Perforated at 1245'. Did not squeeze. Loaded and tested 7" casing to 500 psi. Spotted 35 sx Class "C" cement from 1295'-1080'.  
 6/15/17 - Tagged TOC at 1080'. ND BOP. Spotted 40 sx Class "C" cement from 194' up to surface. Topped off with cement.  
 6/21/17 - Dug up cellar and cut off wellhead. Installed dry hole marker. Covered cellar and cut off all anchors. **WELL IS PLUGGED AND ABANDONED.**
