b. Rig will utilize fresh water based mud to drill 17?? surface hole to TD. Solids control will be handled entirely on a closed loop basis.

2. The wellhead will be installed and tested once the 13-3/8? surface casing is cut off and the WOC time has been reached.

3. A blind flange with the same pressure rating as the wellhead will be installed to seal the wellbore. Pressure will be monitored with a pressure gauge installed on the wellhead.

a. A means for intervention will be maintained while the drilling rig is not over the well.

4. Spudder rig operations is expected to take 8-10 days on a multi well pad.

5. The BLM will be contacted and notified 24 hours prior to commencing spudder rig operations.


6. Drilling operations will be performed with the drilling rig. At that time an approved BOP stack will be nipped up and tested on the wellhead before drilling operations commences on each well.

a. The BLM will be contacted / notified 24 hours before the drilling rig moves back on to the pad with the pre-set surface casing.


7. Devon Energy will have supervision over the rig to ensure compliance with all BLM regulations and to oversee operations.

8. Once the rig is removed, Devon Energy will secure the wellhead area by placing a guard rail around the cellar area.
