Pump 2nd stage w/ 20BFW spacer then cmt w/ 790sx (266bbl) PPC w/ additives 12.9ppg 1.89 yield followed by 185sx (44bbl) PPC w/ additives 14.8ppg 1.33 yield, drop cancellation plug, pressure up & close DVT, circ 237sx (80bbl) cmt to surface, WOC. Install pack-off, test to 5000# for 15 min, good test. 7/12/17 ND BOP & install well head night cap.
