13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Change surface and intermediate hole and casing sizes as follows: Drill 17 1/2" hole to approximately 300', using fresh water spud mud. Set 13 3/8", 48#, H-40, casing with 440 sacks Class C cement (circulate to surface, 1" if necessary).

Drill 12 1/4" hole to approximately 1300', using fresh water and viscous sweeps for hole cleaning. Set 9 5/8", 36#, J-55 casing with 460 sacks Class C cement (lead 50:50 Poz, circulate to surface, 1" if necessary).

Drill 8 3/4" production hole.
