9/12/17 - Spotted 50 sx Class C cement from 1320 ft - 720 ft calc TOC. WOC. Did not tag.
BLM-Carlsbad ok'd to set a CIBP above perfs and circulate cement to surface. Set a 4-1/2 inch CIBP at 1275 ft. Tagged CIBP. Loaded casing and circulated with 30 bbls water. Pressure tested casing to 500 psi, held good. Spotted 100 sx Class C cement from CIBP and circulated up to surface. Topped off well with cement.
9/13/17 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
