RIH & set 5-1/2" 20# P-110 DQX csg @ 19874', pump 100 BBLs mud push then cmt w/ 312 sks (73 BBLs) PPC w/ additives 13.2 PPG, 1.38 yield, followed by 2188 sks (510 BBLs) PPC w/ additives 13.2 PPG, 1.38 yield. Estimated TOC = 6451'. For second stage performed Bradenhead squeeze cementing w/ 182 sks (43 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield, followed by 1020 sks (232 BBLs), 12.8 PPG, 1.76 yield, followed by 191 sks (87 BBLs), 12.8 PPG, 1.33 yield. Ran echometer, TOC = 550'. ND BOP, NU well cap and release rig (12/9/17).
