11/17/17 Drilling 8-3/4" hole, looking for 7" casing point in top of Cisco Reef. Started losing partial returns and called TD at 8620'. Ran 7" casing with DV-ECP combination tool on top of bottom joint of casing.

While running casing and washing down to bottom, ECP set 7' off bottom. Over pulled 2000,000# over string weight but packer was very set and packed off, preventing circulating or cementing bottom joint (1st stage). TD 8620' bottom casing shoe 8613'. Top DV tool 8540'.

Spoke with Ray Podany with OCD (9:30am 11/17/17) and Charles Nimmer with BLM (10:37am 11/17/17) and received permission to open DV and cement from DV up.

Opened DV tool and cemented with 100sx C lead and 700 sx C tail. Circulated 207sx to surface.
