1/16/18 NU BOP, test @ 250 psi low, 5000 psi high, good test. RIH & tag cmt @ 4359', drill new formation to 4430', perform FIT EMW = 10.5 PPG. Drill 8-1/2" hole to 12746' and lost RSS and bit in the hole (1/23/18). Sidetracked wellbore @ 12,500' and drilled to 15026'M 10077'V (1/31/18). RIH and set 5-1/2" 20#, P-110, DQX csg @ 15021', pump 20 BBLs tuned spacer then cmt w/ 230 sks (20 BBLs) PPC w/ additives, 13.2 PPG, 1.57 yield, followed by 1030 sks (296 BBLs) PPC w/ additives, 13.2 PPG, 1.61 yield. Estimated TOC = 6099'. For second stage, performed Bradenhead squeeze, pumping 10 BBLs tuned spacer, then cementing w/ 956 sks (303 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield. Ran echometer, TOC = 1706'. ND BOP, install well cap, release rig (2/4/18).
