3/24/06 Set a CIBP at 5300' with 35' cement on top. Perforate Strawn 5172'-5178' (36), 5192'-5206' (84) and 5234'-5240' (36). Acidize with 1400g 7-1/2% IC HCL and 1400g N2.

3/31/06 Set a CIBP at 5150' with 35' cement on top. Perforate Wolfcamp 4596'-4606' (36). Acidize with 1000g 7-1/2% IC acid.

4/5/06 Set a CIBP at 4590'. Perforate Wolfcamp 4550'-4558' (32) and 4562'-4566' (16). Acidize with 1000g 20% IC acid and 54 balls.
