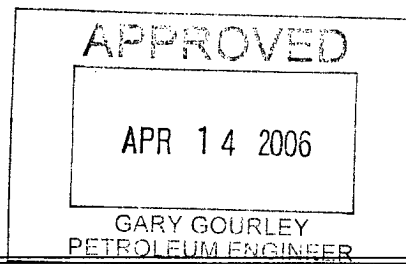

2. MIRU PU, TOH w/ tbg. & pkr, TIH to 6250', Circ. Hole w/ 9# mud laden fluid.
3. Spot 25 sx. Cement plug f/ 6250' to 6050', TOH w/ tbg.
4. RIH w/ 5-1/2" CIBP & set @ 4150', cap w/ 35' cement.
5. TIH w/ tbg., Spot 25 sx. Cement plug f/ 2250' to 2050'.
6. Spot 10 sx. Cement plug @ surface f/ 60' to 0'.
7. Cut well heads off 3' below GL, Install dryhole marker and clean location.
