Set 5-1/2" CBP @ 4070' & PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3686'-4031' w/32-0.40" holes. Treated new Yeso perms w/1000 gal 15% HCL & fraced w/29,850# 100 mesh & 322,100# 30/50 sand in slick water. Spotted 500 gal 15% HCL across next stage. Set 5-1/2" CBP @ 3600' & PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3200'-3506' w/27-0.40"
