Plug down @ 1:45 PM 05/02/18. Circ 112 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 2:30 A.M. 05/04/18, tested csg to 1500#, held OK. Drilled out with 12 1/4" bit.

05/06/18..TD'ed 12 1/4" hole @ 2467'. Ran 2452' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 400 sks Class C w/additives. Mixed @ 11.8#/g w/ 2.61 yd. Tail w/250 sks Class C Neat. Mixed @ 14.8/g w/1.32 yd. Displaced w/183 bbls FW. Plug down @ 6:15 PM 05/06/18. Circ 135 sks of cmt to the pits. Set Cameron mandrel hanger through BOP w/85k#. At 5:00 A.M. 05/07/18, tested csg to 1500#, held OK. FIT test to EMW of 9.5 PPG. Drilled out with 8 3/4" bit.
