5/30/18 - Tagged CIBP. Circulated 40 bbls water. Pressure tested to 500 psi, held good. Spotted 125 sx Class "C" cement from 1259' up to surface. Topped off well with cement.  
6/19/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
