Plug down @ 12:45 AM 07/12/18. Circ 80 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 8:30 A.M. 07/13/18, tested csg to 1500#, held OK. FIT test to 10.2 PPG EMW. Drilled out with 12 1/4" bit.

07/14/18..TD'ed 12 1/4" hole @ 2550'. Ran 2536' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 450 sks Lite Class C (50:50:10) w/additives. Mixed @ 11.9#/g w/ 2.47 yd. Tail w/200 sks Class C Neat. Mixed @ 14.8/g w/1.32 yd. Displaced w/189 bbls FW. Plug down @ 1:15 AM 07/15/18. Circ 198 sks of cmt to the pits. Set Cameron mandrel hanger through BOP w/100k#. At 11:00 A.M. 07/15/18, tested csg to 1500#, held OK. FIT test to EMW of 9.6 PPG. Drilled out with 8 3/4" bit.
