05/16/2018 to 05/22/2018

Drill 17 1/2 inch hole, TD at 3814. Run 13 3/8 inch casing to 3814. Cmt casing with 2466 sxs lead and 548 sxs tail cmt. Cmt did not circulate. Run temp log and found TOC at 300 ft. Perform 1 inch top off job per BLM, using 44 bbls cmt, yield cmt to surface. Test casing to 1500 psi (good).
