 8/20/18 – Tagged TOC at 3763'. Circulated 100 bbls packer fluid from TOC 3763' to surface. Pressure tested 5-1/2" casing to 500 psi, held good. Gilbert Cordero with Artesia NMOCD was on location to witness MIT. Pressured up on 5-1/2" casing to 500 psi. Recorded on calibrated chart for 30 min, held good. Bled down pressure.
