Plug down @ 10:00 PM 06/30/18. Circ 167 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 11:15 P.M. 07/01/18, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.
