6-6-2003 - Moved in pulling unit and plugging equipment. Hunted for anchors. Moved pumping unit out of the way. Spotted rig. Shut down for night.

6-7-9-2003 - Rigged up pulling unit. POOH with rods and pump. Nippled down wellhead and nippled up BOP. Rigged up floor and 2-3/8" tubing equipment. POOH with tubing. Shut well in for night.

6-10-2003 - RIH with tubing and tagged CIBP at 2700'. Circulated hole with plugging mud. Spotted 25 sacks Class C Neat cement. POOH with 40 joints. Shut well in for night.

6-11-2003 - RIH with tubing and tagged plug at 2410'. Circulated hole clean. POOH with tubing. Rigged up wireline. RIH and perforated 4-1/2" casing at 1280'. POOH and rigged down wireline. Dug out cellar. RIH with packer and tubing to 995'. Squeezed with 45 sacks Class C Neat cement. Displaced to 1180'. Shut well in for night. WOC.

6-12-2003 - Pressured up to 750 psi, held okay. POOH with packer and tubing. RIH open ended and tagged plug. POOH with tubing. Shut well in for night.



SUNDRY NOTICE CONTINUED:

6-13-2003 - Rigged up wireline. RIH and perforated 4-1/2" casing at 570'. POOH and rigged down wireline. Rigged down tubing equipment and floor. Nippled down BOP and casinghead. Installed 4-1/2" X 2" swedge with valve. Squeezed with 140 sacks Class C Neat cement. Shut well in. WOC 4 hours. RIH and tagged plug at 230'. POOH. Shut well in for night.

6-14-16-2003 - Rigged up wireline. RIH and perforated 4-1/2" casing at 150'. POOH and rigged down wireline. Squeezed with 100 sacks Class C Neat cement down 4-1/2" casing. Shut well in for night. WOC.

6-17-2003 - RIH and tagged plug at 69'. Filled 4-1/2" casing from 69' to surface & 8-5/8" casing with 65 sacks Class C Neat cement. WOC 4 hours. Cement stayed at surface. Rigged down pulling unit and plugging equipment. Installed regulation abandonment marker. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 6-16-2003.
