Cemented with 275 sx 35:65 Poz Class C + 3% S1 + 6% D20 + 1/4 pps D130 lead (12.6 ppg, yld 1.99) and 200 sx Class C + 2% S1 tail (14.8 ppg, yld 1.32). No returns. Ran 1" pipe down backside, tagged at 357'. Topped out with 7 cement plugs (5) 255 sx, (1) 50 sx, & (1) 85 sx of Class C Neat. WOC 36 hrs. Test casing to 1000 psi for 30 min. Drill 7-7/8" hole to 7630'. Ran 36 jts 5-1/2", 17# and 158 jts 15.50# J-55 LTC casing & set at 7630'. Cemented with 875 sx LiteCrete + 2 pps D153 + 2 pps D24 + 0.05 gps D604 + 0.03 gps M45 + 0.04 gps D801 lead (10.2 ppg, yld 2.4). 225 sx LiteCrete + 2 pps D153 + 2 pps D24 + 0.05 gps D604AM + 0.03 gps M45 + 0.04 gps D801 tail (10.5 ppg, yld 2.23). TOC by temperature survey 3900'. Released rig at 1:00 am CST on 4/19/06. Prep for completion.
