11/28/18 MIRU plugging equipment. ND pump jack head. Unseated pump. POH w/ rods & pump. Dug out cellar. Well had gas flow. Pump'd 20 bbls of brine to kill well. POH w/ tbg. Set 5 1/2" CIBP @ 2300'. Gas flow stopped. Circulated hole w/ salt gel. Pressure tested csg, held 500 psi. Spotted 45 sx class C cmt @ 2300-1845'. WOC. 11/29/18 Tagged plug @ 1800'. Spotted 25 sx class C cmt @ 900-650'. WOC. Tagged plug @ 640'. Perf'd csg @ 557'. Established injection rate but would not circulate. Pressured up to 500 psi. ND BOP. Spotted 80 sx class C cmt @ 640' & circulated to surface. Riggged down & moved off. 12/03/18 Moved in backhoe and welder. Dug out cellar. Cut off well head. Verified cement to surface. Welded on "Above Ground Dry Hole Marker". Backfilled cellar, cut off deadmen, cleaned location and moved off.
