Mixed @ 14.8#/g w/ 1.34 yd. Displaced w/60 bbls of FW. Plug down @ 8:30 AM 02/10/19. Circ 331 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 6:00 A.M. 02/12/19, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.
