

Devon Energy Production Company, LP request approval to recomplete to the Morrow as follows:

- MIRU PU. Load hole w/30 bbls 2% KCl. ND tree & NU BOP.
- Rel pkr & POOH. RIH w/4 1/2" cmt retainer & 2 3/8" tbg to 12,930'. Pump through retainer. Set retainer & sting out of retainer. Sting into retainer & squeeze perms w/100 sx Cl H. Sting out of retainer & reverse tbg clean. POOH w/tbg.
- RIH w/bit, DC's, & tbg & drill out retainer & cmt. Test squeeze to 1000 psi. RIH to sand fill @ ±13,300'. Drill out sand to top of guns @ ±14,083'. POOH.
- RIH w/pkr & 2 3/8" tbg to 13,810'. Circ 2% KCL w/pkr additives & set pkr. ND BOP & NU tree. Swab well down to 8000'.
- RU Baker Atlas WL. RIH w/1 11/16" Predator guns & perf Morrow 4 SPF (90° phased) from 13,911-16' (20 holes). RD WL.
- RIH w/swab if necessary & swab well down to pkr. Evaluate for stimulation.
