6/5/03 Resumed drilling at 7:00 AM.
6/9/03 Set 9-5/8" 36# casing at 1600'. Cemented with 200 sx Premium Plus with additives and 900 sx Halliburton Lite Premium Plus with additives. Tailed in with 250 sx Premium Plus with additives.
Cement did not circulate. Ran 1" cement to surface with 375 sx Class "C" with additives. WOC 48 hrs 15 mins. Reduced hole to 8-3/4" and resumed drilling.
