The Operator respectfully requests to preset the surface casing on the subject well, the depth, casing, and cement will not change from the previous sundry. Below is a description of the preset operations.

Description of operations

- Spudder rig will move in to drill the surface hole and pre-set surface casing on the well.
 - After drilling the surface hole section, the spudder rig will run casing and cement following all of the applicable rules and regulations (OnShore Order 2, all COAs and NMOC regulations)
 - The spudder rig will utilize fresh water-based mud to drill the surface hole to TD. Solids control will be handled entirely on a closed loop basis. No earth pits will be used.
- The wellhead will be installed and tested as soon as the surface casing is cut off and the WOC time has been reached.

3. A blind flange at the same pressure rating as the wellhead will be installed to seal the wellbore. Pressure will be monitored with needle valves installed on the wing valve.
4. Spudder rig operations are expected to take 2-3 days per well on the pad.
5. The BLM will be contacted and notified 24 hours prior to commencing spudder rig operations.
6. Drilling operations will begin with a larger rig and a BOP stack equal to or greater than the pressure rating that was permitted will be nipped up and tested on the wellhead before drilling operations resume on each well.
 - a. The larger rig will move back onto the location with 90 days from the point at which the wells are secured and spudder rig is moved off location.
 - b. The BLM will be contacted / notified 24 hours before the larger rig moves back on the pre-set locations
7. Operator will have supervision on the rig to ensure compliance with all BLM and NMOCD regulations and to oversee operations.
8. Once the rig is removed, Operator will secure the wellhead area by placing a 1 inch steel plate over the cellar and wellhead.
