180 sx 35/65 P/C + 5% PF44 (BWOW)(Salt) + 6% PF20 (Bentonite Gel) + 3#/sk PF42 (Kolseal) + 0.125#/sk PF29 (Celloflake) + 0.4#/sk PF45 (Defoamer).
