6-10-2019 Tagged cement @ 7822' have 245' of cement above top perforation.

6-12-2019 Set 25sx plug @ 7650', set 25sx plug @ 6350', set 25sx plug @ 5250', set 25sx plug @ 3050',.

6-13-2019 Set 25sx plug @ 2500' attempted to squeeze but couldn't.

6-14-2019 Tagged plug @ 2360' that was set @ 2500' on 6-13-2019.

6-17-2019 Perforated @ 1690 set 30sx plug. Perforated @ 357'.
