08/09/19 Spud 17 1/2" hole. TD 17 1/2" hole @ 395'. Ran 380' of 13 3/8" 54.5# J55 ST&C Csg. Cemented with 250 sks Class C w/additives. Mixed @ 12.0#/g w/2.51 yd. Displaced w/52 bbls of BW. Plug down @ 11:30 AM 08/10/19. Circ 45 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 7:45 P.M. 08/11/19, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.

08/14/19 TD 12 1/4" hole @ 1790'. Ran 1775' of 9 5/8" 40# N80 LT&C Csg. Cement with 250 sks Class C w/additives. Mixed @ 11.5#/g w/2.63 yd. Tail w/200 sks Class C w/1% CaCl2.
