Plug down @ 10:15 AM 09/23/19. Circ 105 sks of cmt to the pits. Tested BOPE to 5000# & Annular to 3500#. At 9:30 A.M. 09/24/19, tested csg to 1500#, held OK. FIT test to 10.2 PPG EMW. Drilled out with 12 1/4" bit.

09/25/19. TD'ed 12 1/4" hole @ 2483'. Ran 2468' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 525 sks Class C (35:65:6) w/additives. Mixed @ 12.9#/g w/1.83 yd. Tail w/200 sks Class C Neat. Mixed @ 14.8/g w/1.32 yd. Plug down @ 12:15 AM 09/26/19. Circ 154 sks of cmt to the pits. Set Universal mandrel hanger through BOP w/60k#. At 10:00 A.M. 09/26/19, tested csg to 1500#, held OK. FIT test to EMW of 10.0 PPG. Drilled out with 8 3/4" bit.
